RETIREMENT BOARD MEETING MINUTES

A regular meeting of the Board of the Public Employee Retirement System of Idaho was held at 607 North 8th Street, Boise Idaho starting at 8:35 a.m., October 14th, 2025.

At 8:35 a.m., Chairman Cilek called the meeting to order.

APPROVAL OF THE BOARD MEETING MINUTES

Trustee Price moved to approve the minutes of September 16th and September 24th, 2025, Board meetings. Trustee DeAngeli seconded the motion. The motion passed unanimously.

INVESTMENTS/PORTFOLIO

Monthly Portfolio Update

Richelle Sugiyama presented the investment update. As of October 7^{th} , 2025, the fiscal year-to-date return of +4.5%, trailed the policy benchmark due to the strong performance of the Russell 3000 Index. Ms. Sugiyama noted the underperforming asset classes, the positive contributions of the international and emerging market asset classes, and highlighted Donald Smith, AB, Sprucegrove, and WCM as outperforming their respective benchmarks for the period. She also commented on the escalating global trade war tensions and related market volatility since the October 7^{th} report.

Rhet Hulbert (Clearwater Advisors) and Brandon Fitzpatrick (D.B. Fitzpatrick & Co.) provided current stock market insights, an update on trade war tensions with China, and the potential long-term effects of the government shutdown.

OPERATIONS AND ADMINISTRATION

Actuarial Sustainability Modeling

Robert Schmidt and Ryan Falls reviewed how sustainability modeling can be used as a tool to help understand the long-term impact of current decisions, involving contribution rates and discretionary postretirement allowance adjustments (PAA).

Postretirement Allowance Adjustment Discussion

The Board discussed the importance of maintaining the health and sustainability of the fund, even if it means making difficult decisions regarding contribution rates and PAA.

Actuarial Valuation Adoption Decision

Mike Hampton presented the final FY25 valuations for the Idaho Judges Retirement Plan (JRF), Firefighters Retirement Fund (FRF), State and School Sick Leave Plans, and the PERSI Base plan. Trustee DeAngeli moved to adopt FY25 valuations as presented, Trustee Wolff seconded, and the motion passed.

<u>Fairness Adjustment Setting</u>

Mike Hampton presented a review of the fairness adjustment review to the Board, recommended taking no action at this time. No further decisions were made.

Annual Contribution Rate Setting

Mike Hampton discussed the setting of the annual contribution rate, and the decision was to bring this issue back in the Spring of 2026.

Idaho Code Cleanup Act Update

Mike Hampton gave an update on PERSI's two Executive Agency Legislative Ideas and status regarding PERSI's compliance with the Idaho Code Cleanup Act. PERSI is awaiting further communication back from the newly formed Idaho Department of Government Efficiency (DOGE) task force which is now reviewing the Idaho Code Cleanup suggestions that were submitted to the Division of Financial Management and Legislative Services Office.

Fiscal Update/Travel/Expense Report Update

Mike Anderson provided the Board with the monthly expenses and travel report.
