SECURELY SEND EMAIL TO PERSI

PERSI is using TLS (Transport Layer Security) encryption to help secure email communication.

A TLS connection encrypts and delivers mail securely for both inbound and outbound mail traffic. It helps prevent eavesdropping between mail servers, keeping your messages private while they're moving between your email server and ours. PERSI can set up TLS encryption between PERSI and your organization.

CURRENT FORMS ARE ONLINE

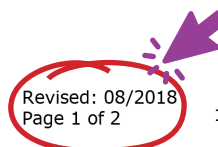
When submitting an employer form to PERSI, please make sure it is the most current version.
