DIRECTOR DRUM COMPLETES HIS TERM AS BOARD PRESIDENT OF THE NATIONAL ASSOCIATION OF STATE RETIREMENT ADMINISTRATORS

This past August, at the 68th National Association of State Retirement Administrators (NASRA) conference, Director Drum completed his term as President. The Plan Sponsor Council of America recently invited PERSI Training Specialist, Maria Sablan-Quitugua, to contribute an article about the importance of connecting with employees and employers.

Her article, "Relationships Matter!", shares her unique perspective as a public service employee educating Idaho's public workers about PERSI retirement benefits and the role professional relationships play in successfully reaching members.

Ms. Sablan-Quitugua explains how building rela-

tionships, builds partnerships:

"It is important to build relationships with your points of contact. You have probably heard this a lot in business and workplaces; they say, "Build camaraderie because it helps cultivate a good working environment." Camaraderie comes from the French language, and it is the origin of English's "comrade," meaning friend or associate. In other words, be a friend and be personable. Communicate that you understand the complexities of scheduling and you are willing and patient enough to work it through. Build trust and be flexible.

Provide employee education and employer support. Offer workshops that enable employers to take a proactive, data driven role in their employee educa-tion; it requires a lot of communication and correspondence.

'I want our employee members to be "retirement literate" and to help them realize the value of their benefits.'

Collect data and resources prior to reaching out so you can be ready to plan for workshops that are customizable to fit their needs. Gathering information ahead of time shows your contacts that they are important because you invested your time in them. It shows that you are serious, that they are important, and you mean business.

I gather data like employee count, length of service, type of agency/employer etc. I want employers to know that I am here to help their employees, but I am also here to help them recruit and retain their employees."
